NOTIFICATION

New Delhi, the 24th March, 2014

G.S.R. 68.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Administration of Daman and Diu, Principal, Technical Training Institute, (Group 'A' Gazetted) post Recruitment Rules, 2004, except as respects things done or omitted to be done before such suppression, the President hereby makes the following rules regulating the method of recruitment to the Posts of Principal (Group 'A') in Technical Training Institute, Directorate of Technical Education, Daman, namely:—

1. Short title and commencement.—(1) These rules may be called the Technical Training Institute of Daman and Diu (Principal Group 'A' Post) Recruitment Rules, 2013.

(2) These rules shall come into force from the date of their publication in the Official Gazette.

2. Number of post, classification and Pay Band and Grade Pay or Pay Scale.—The number of posts, classification of the said posts and scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualification etc..—The method of recruitment, age limit, qualifications and other matters related thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification.—No person,—

(a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation:

Officers of the Central or State Government or Union Territories :

(A) (i) Holding analogous post on a regular basis in the parent cadre or department; OR

(ii) With two years service in the grade rendered after appointment thereto on a regular basis in the Pay Band-2 of Rs. 9300-34800 + Grade Pay of Rs. 4800 or equivalent in the parent cadre or department; and

(B) Possessing the Educational Qualifications and experience prescribed for direct recruits under column 7.

(The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion).
