(3) Method of recruitment, age limit, qualifications etc:

The method of recruitment to the said post, age limit, qualification and other matters relating therewith shall be as specified in Column 5 to 13 of the aforesaid Schedule.

(4) <u>Disqualification</u>:

No Person, (a) who has entered into or contracted a marriage with a person having a spouse living or, (b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service.

Provided that the Administrator of Daman & Diu, may, if satisfied that such marriage is permissible under the personnel law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

(5) <u>Power to relax</u>:

Where the Administrator is of the opinion that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

(6) Saving:

Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, and the other special categories or persons in accordance with orders issued by the central Government from time to time in this regard.

Read: Notification No. FSSA/DD/DMN-GUTKHA/2012-13/204 dated 19.04.2014

WHEREAS, vide Notification No. FSSA/DD/DMN-GUTKHA/2012-13/204 dated 19/04/2014, the manufacture, storage, distribution or sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market and any other products marketed separately to constitute as Guthka or Pan Masala, etc. as final product, was prohibited by the Commissioner Food Safety, UT of Daman and Diu, in exercise of power conferred by clause (a) of sub-section (2) of Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006), for a period of one year w.e.f. 1st May, 2014.

AND WHEREAS it is expedient in the interest of public health to extend the period of the above prohibition beyond the period covered by the notification referred to above.

NOW, THEREFORE I, the Commissioner of Food Safety, UT of Daman and Diu, in exercise of the powers conferred by clause (a) of sub-section (2) Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006), in the interest of public health, hereby prohibit the manufacture, storage, distribution or sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market and any other products marketed separately to constitute as Gutkha or Pan Masala, etc. as final product, are hereby prohibited in the whole UT of Daman and Diu, extended for a further period of one year with effect from 1st May, 2015.
