## ORDER

#### Prohibition on Manufacture, Storage, Distribution and sale of Maggie Noodles

Whereas seven samples of Maggie noodles manufactured by M/s. Nastle were collected for test and analysis on 23/05/15 & 04/06/2015 and have been sent for testing to Food Analyst, Food & Drug Laboratory, Vadodara, Gujarat.

- 2. And whereas it has been reported that Maggie noodles were containing higher than permissible limits of Lead and presence of Monosodium Glutamate in their products in many states.
- 3. And whereas it is found that consumption of Maggie noodles may thus lead to health problems like adversely affecting the heart, bones, intestines, kidney, reproductive and nervous systems, and the consumption of excess of Monosodium Glutamate causes allergic reactions to skin and also affects the nervous system.
- 4. And Whereas the Commissioner of Food Safety for UT of Daman & Diu is empowered under Section 30 of the Food Safety and Standard Act 2006 to prohibit in the interest of public health the manufacture, storage, distribution or sale of any article of food in the whole of the U.T.

5. Now, therefore I, the Food Safety Commissioner of UT of Daman & Diu in exercise of the powers conferred by Clause (a) of sub section (2) of Section 30 of the Food Safety and Standards Act 2006 (34 of 2006) in the interest of public health hereby prohibit the manufacture, storage, distribution or sale of Maggie noodles by whatsoever names these are available in the markets and any other products marketed separately to constitute as noodles as final products in the UT of Daman & Diu for a period of 30 days from the date of this order.

The above mentioned committee will be responsible for complying with the following directions of Hon'ble Supreme Court:-

- 1. The Committee should put in place a procedural mechanism, which would ensure that the cause of justice is served, which would simultanesouly ensure the safeguard of interest of those who are innocent.
- The committee will incorporate in its existing training programmes for junior investigation/prosecution officials course-content of refresher training programme, for Senior investigating/prosecuting officials. The responsibility for preparing training programmes should be vested in the same committee.
- 3. The committee shall meet quarterly to review and will consider the lapses in investigation/prosecution as pointed out by the Hon'ble Supreme Court in the said judgment dated 07.01.2014, to ensure that such lapses do not occur.
- 4. The committee will formulate a procedure for taking action against all erring investigation/prosecuting officials/officers. All such erring officials/officers identified, as responsible for failure of a prosecution case, on account of sheer negligence or because of culpable lapses, would be liable for departmental action.
