- iii) The units under this scheme should be operated at least for the minimum period of two years.
- iv) The participants shall have no maintain the prescribed recordes and furnish the prescribed information to the Deputy Director (Animal Husbandry) DAMAN & DIU from time to time.
- v) The participants shall have to follow the instructions issued by Department of Animal Husbandry & Veterinary Services, DAMAN & DIU.
- vi) The financial assistance should be used only for the purpose for which it may be granted.
- vii) In case of breach of any of the aforesaid terms and conditions, the entire amount of assistance shall be recoverable from the beneficiaries as per law (subject to Daman Jurisdiction) if necessary.
- viii) The participants shall have to execute a bond to the effect that the aforesaid terms and conditions are acceptable to him/it and he/it will abide by all of them failing which he will liable to be prosecuted as per the existing rules of the Administration.
- ix) (a) The Ext. Officer (Dairy)/Veterinary Officer, DAMAN & DIU; would disburse the assistance in the form of subsidy after completion of poultry unit in respect of construction of poultry shed which should be of low input technology,
 - (b) Purchase of Pullets, feed or equipment directly to the individual supplier or body or an approved agency or institution.
- Completion certificate for small scale poultry unit should be obtained from,
 - (a) Field Level Worker i.e. Veterinary Stockman or Poultry Field Assistant,
 - (b) The certificate should be countersigned by concerned Veterinary Officer (D.P) or (Vet. Officer Hospital).
- xi) Beneficiary has to compulsorily sale/supply the surplus eggs to the nearby school under the scheme of Mid-Day Meals.
- xii) Education Officer/Veterinary Officer (District Panchayat) will do fortnightly payment to the beneficiary for supply of eggs regularly.

NOTIFICATION

In supersession of the Notifications referred to above, the Administrator, UT of Daman & Diu, is hereby pleased to re-notify the Matru Samrudhi Yojana (MSY) scheme for implementation in order to extend the benefits to Pregnant Women with effect from date of publication of the Notification in Official Gazette of UT Administration of Daman & Diu.

2. The objective of the Scheme are as follows:

- Discourage early Marriages.
- ii. Promote registration of Marriages.
- iii. Promote Institutional Deliveries.
- iv. Reduction in Maternal Mortality and Infant Mortality.
- v. Reduction in Net Reproduction Rate.

3. Assistance to the Couple:

Cash assistance of Rs. 5,000/- (Rupees five thousand only) to each beneficiary Mother in her bank account as Cash benefit under the Scheme from UT Administration Plan Fund.

4. Eligibility:

- i. Marriage of expectant mother not before the age of 18 years.
- ii. The delivery should have taken place at a Government Health Institution of UT of Daman & Diu.
- iii. The benefit shall be extended only upto to first two live births to each mother.

iv. Either one of the Parents must be resident of UT of Daman & Diu, or

the Expectant Mother is registered under Mother & Child Tracking System (MCTS) & MCTS ID has been generated and the expectant mother must have undergone atleast 3 Antenatal Check-ups as per the RCH scheme to be duly certified by the concerned ANM/Field Health Functionary of the respective Sub-Centre, both regarding ANC checkups as also regarding residence in Daman / Diu, and countersigned by the Supervisor in the concerned Sub-Centre.

5. The Director Medical & Health Services, Daman & Diu shall be consulted in the event of any doubt.
