### **NOTIFICATION**

In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. AB. 14017/61/2008–Estt. (RR) dated 24<sup>th</sup> March, 2009, the Administrator of Daman & Diu and Dadra & Nagar Haveli is placed to make the following Rules relating to recruitment to the General Central Service Group 'C' Non – Ministerial, Non – Gazetted post of Field Assistant in Department of Agriculture under the Administration of Daman and Diu, namely :

### 1. Short title and commencement:

- (i) These rules may be called Administration of Daman & Diu, Department of Agriculture, General Central Service Group 'C' Non Ministerial, Non Gazetted posts Recruitment Rules, 2016.
- (ii) They shall apply to the posts specified in column 1 of the schedule to these Rules.
- (iii) These rules will come into effect from the date of publication of this Notification in the official Gazette and will relate to appointment to the various posts made on or after this date.

### 2. Number of post, classification and sacle of pay:

The number of posts, its classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed to these rules.

### 3. <u>Method of recruitment, age limit, qualifications etc</u>:

The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 5 to 13 of the Schedule.

### 4. <u>Disqualification</u>: No person,

a. Who has entered into or contracted a marriage with a person having a spouse living, or

b. Who, having a spouse living, has entered into or contracted marriage with any person shall be eligible for appointment to the said posts. Provided, that the Central Government, if satisfied that such marriage is permissible under the personnel law applicable to such person and the other to the marriage and that there other grounds for so doing, exempt any person from the operation of this rule.

### 5. Power to relax:

Where the Central Government is of the opinion that it is necessary or expedient so to do, it may be order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

### 6. Saving:

Nothing in these rules shall affect reservations relaxation of age limit and other concessions required to be provided for Scheduled Castes and Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the central Government from time to time in this regard.

These rules are issued in super session of the existing Recruitment Rules for the posts.
