In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. AB.14017/61/2008 – Estt. (RR) dated 24th March, 2009, the Administrator of Daman & Diu and Dadra and Nagar Haveli is placed to make the following Rules relating to recruitment to the General Central Service Group "C" (Non–Ministerial), (Non–Gazetted) post of **Excise Guard** in Excise Department, Daman under the Administration of Daman and Diu, namely:-
