## ORDER

No. 7-11/EC/DD/2015: Whereas, the Administrator of Daman and Diu has determined the total number of seats and the seats to be reserved for women, the Scheduled Castes and the Scheduled Tribes and women belonging to these castes/tribes in the Diu Municipal Council vide Notification No. UD/DMN/Muni/Res./Women/99/2017/03 dated 5<sup>th</sup> April, 2017, giving hereby one seat to Scheduled Castes women and Six seats to general women:

And, whereas, the thirteen wards of Diu Municipal Council have been delimited by the Election Commission for the Union Territory of Daman and Diu, appointed under Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, that was notified in the Official Gazette of Daman and Diu vide Notification No. 7-15/EC/DD/2017 dated 5<sup>th</sup> April, 2017;

And, whereas, Rule 3 (1) (b) of the Daman and Diu Municipalities (Elections) Rules, 1995 provides that "wards in which seats are reserved for the Scheduled Castes, the Scheduled Tribes, Women belonging to these castes or tribes or women shall, as far as practicable, be distributed in different parts of each Council";

And whereas, Rules 3(1) (c) of the said Rules provides, inter alia, that "the seats reserved under clause (b) may be rotated by the Commission by draw of lots separately for the Scheduled castes, the Scheduled Tribes and the women so that it is ensured that seats are so reserved in favour of such castes, tribes or women in all the wards before such reservation is made in respect of a ward for the second time for that category";

And in compliance thereof and keeping in view the reservation order of seats for general women and Scheduled Castes women in the general election, 2012, a public draw of lots was held in the Conference Hall of Diu Municipal Council, Diu, on 09/05/2017 in the presence of representatives of political parties and other interested in the subject;

Now, in pursuance of Section 9(4) of the Daman and Diu Municipalities (Amendment) Regulation, 1994 read with rule 3 (1) (b) and (c) of the Daman and Diu Municipalities (Election) Rules, 1995, the Election Commission, following the principle of rotation and after draw of lots held at Diu, hereby allots the seats reserved for women, the Scheduled Castes, and women belonging to the Scheduled Castes to the following wards for the purpose of the forthcoming general election to the Diu Municipal Council:-
