#### Declaraation of VDA under the Minimum Wages Act, 1948.

In addition to the Basis Pay fixed by the Administration of Daman & Diu in respect of all the scheduled employments under the Minimum Wages Act, 1948 vide notification No. LE/LI/DMN/MWA-3(II)/2015-16/81 dated 29.05.2015, the daily rate of Special Allowance payable on the basis of cost of living index number is hereby increased at the rate of ₹ 8.80/- for a period from 01.04.2017 to 30.09.2017. Hence considering the earlier daily rate of Special Allowance, the total rate of daily Special Allowance, payable is as under :-

- 9. Inspection under The Shops and Establishments Act (as applicable)

#### ORDER

In pursuance of the reforms proposed by the DIPP, Ministry of Commerce & Industry, New Delhi the Inspection Reforms Enablers to be implemented under the various labour laws are as under :

INSPECTION PROCEDURE FOR CARRYING OUT INSPECTIONS BY THE LABOUR COMMISSIONER & OFFICERS / INSPECTORS OF THE LABOUR DEPARTMENT.

- > Inspections are carried out by Inspectors on the basis of complaints or references received from Commissions, various Departments, Ministries etc. or on directions received from higher authorities.
- > The Complaints are generally received from workers, Trade Union representing workers.
- > Inspections are carried out by Inspectors normally within 30 days of receipt of complaint.
- > Notices under various Labour Laws are issued to the Employer on the spot for compliance of irregularities detected during the course of inspection.
- > Inspection reports are put up within 24 working hours of inspection to higher authorities and will be uploaded on website.
- > For non-compliances, which are not complied with by the management despite issuing notices, prosecution besides taking other legal actions; is filed before the competent Court of Law.
- > A final report is submitted to higher authorities after completion of all administrative/legal process & complainant is intimated accordingly.
- > Same Inspector (in case of 2 or more Inspectors) will not inspect same establishment twice consecutively.
- > Allow self certification for low risk Industries without conducting physical inspections under all labour laws.
- > Allow for third party Certifications instead of Department Inspections under all labour laws by the agencies notified by the Government of India/as per the adjoining states.
- Selection of Establishment for inspection will be done using computerized risk assessment and automated allocation of Inspectors as per the orders of the Labour Commissioner.

In pursuance of the reforms proposed by the DIPP, Ministry of Commerce & Industry, New Delhi the Inspection Reforms Enablers to be implemented under the various labour laws are as under:

Brief description of low, Medium and High risk Factories/Establishment

- (1) Low Risk: Factories except as specified in clause (3) employing up to 20 workers are to be inspected only if there are complaints of noncompliance of various Labour laws, accidents and dangerous occurrences. Establishment employing up to 20 workers are to be inspected only in case of complaints regarding non-compliance of various Labour laws/ Labour situation.
- (2) Medium Risk: Establishment/Factories except as specified in (3) employing more than 20 workers and up to 100 workers.
- (3) High Risk: Major Accident Hazard and other chemical factories, factories carrying out dangerous operations of the Factories Act, 1948 and section 2 (cb) of the Factories Act, 1948 and all factories/establishments employing 100 or more workers.

#### UNSCHEDULED INSPECTION

In case of Labour situation, complaint under Labour Laws, accident and dangerous occurrence, survey of unregistered factories or any notice/intimation received at the concerned office, officer/inspector shall be sent for inspection/visit immediately by the Labour Commissioner.

Allocation of Establishments to be inspected by Inspecting officers during the month is carried out on the basis of random allocation by the system on the components of criteria as follows:

Based on the complaints received from workmen 1 Union or any notice intimation received at Labour Commissioner Office/Chief Inspector of Factories & Boilers Officer, Dy. Labour Commissioner Office and Labour Inspector Office.
