In the exercise of the Powers vested to him, the Hon'ble Administrator of Daman & Diu and Dadra & Nagar Haveli is pleased to amend scheme of Suryodaya Awas Yojana as under:

1. Short Title of Scheme – This scheme may be called Suryodaya Awas Yojana–2017

2. Eligibility:-

(i) Any resident of Daman & Diu whose name is registered/entered in survey SECC–2011 and does not have their own land shall be eligible for benefit under scheme.

- (ii) The resident of Daman & Diu whose name has not been included in survey SECC–2011, but found eligible as per guidelines of PMAY–G by the Appellate Committee of Daman & Diu District and does not have their own land shall also be eligible for benefit under the scheme.
- (iii) The Competent authority with the sanction of Administrator, may extend the benefit of the scheme to other eligible beneficiaries as per scheme of Pradhan Mantri Awas Yojana (Gramin).

3. Design and Construction:-

The minimum unit (house) size shall be 25 Sq. Mts. including dedicated area for hygienic cooking.

4. Cost :-

The Estimated cost shall be minimum Rs. 2.90 Lacs (per house).

5. Pattern of Assistant:-

A total financial assistance of subsidy up to Rs. 2.90 Lakh shall be given to the beneficiaries as detailed below :-

- a) Rs. 0.50 Lakh contribution from beneficiaries.
- b) 2.40 Lakh as UT Share. (subsidy)

6. Mechanism of Funds Transfer :-

(i) Assistance (subsidy) would be released in 3 installments linked with stages of construction in the following pattern:

(ii) Stage of constructions and release of installments :-

- 1. The $\mathbf{1}^{\text{st}}$ instalment would be released after excavation of foundation by the beneficiaries i.e. 1/3 of total unit cost (i.e. Rs. 80,000/-)
- 2. The 2^{nd} instalment would be release on reaching the Intel level. It would be 1/3 of the total unit cost (i.e. Rs. 80,000/-)
- 3. The 3rd instalment would 1/3 of the total unit cost and be given only after completion of house including roofing (i.e. Rs. 80,000/-)
- 4. All Payments shall be made to the beneficiaries Bank Account through DBT.

7. Group Housing:

i. The competent Authority may consider the construction of houses in this scheme for beneficiaries, as Group Housing Project.

ii. When the Competent Authority considers the Group Housing Project, the land shall not be released to beneficiaries.

- iii. Each Beneficiary shall deposit Rs. 50000/- with the Implementing Agency, before allotment of house.
- iv. Excess cost, if any, for Group Housing Project above the limit presented under clause 4 shall be bear by U.T. Administration of Daman & Diu.

8. Implementing Agency:-

District Panchayat Daman & Diu shall implement the scheme in Daman & Diu District respectively as under:-

- 1. A Group Housing project approved by Competent Authority empowered under the Daman & Diu Awas Yojana.
- 2. The Implementing Agency may empanel any Consultant and Agency for Construction of the Group Houses.

9. Competent Authority:

The Secretary (PRI), Daman shall be Competent Authority for the purpose of this Scheme.

This shall come into force with immediate effect.
