NOTIFICATION

Whereas under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention and Control of Pollution) Act, 1981 it is required to obtain consent form the Pollution Control Committee to establish or to take any steps to establish, operate or process or any treatment and disposal system which is likely to discharge sewerage or trade effluent into stream or on land and also to operate any industrial plant.

Whereas the Union Territory Administration of Daman and Diu and Dadra Nagar Haveli vide notification No. PCC/DMN/13-(Part-IV)/98-99/2014-15/1199 dated 9/10/2015 and No. PCC/DMN/13-(Part IV)/98-99/2014-15/1200 dated 9/10/2015 classified industries into Category-III, Category-II, Category-I of industries.

Whereas representations were received from industrial associations and several industries which are existing and the manufacturing products falling under Category-I requesting to grant them permission for modernization/expansion/enhancement of production capacity/establishment of additional facility so as to increase in the efficiency of plant and machinery and/or replace some worn out plant and machinery which could incidentally also increase the production capacity and the efficiency of their plant.

Whereas it is essential to facilitate regulated industrial growth of industries and after taking into consideration of the environmental protection of the Union Territories of Daman and Diu and Dadra Nagar Haveli, it is decided to amend the Preamble and the note of the Category-I,

Now therefore the Administrator, Daman Diu and Dadra Nagar Haveli in exercise of the powers conferred by sub-section (I), read with clause (v) of sub-section 3 and clause (e) of Sub-Section (2) of section 6 of Environment (Protection) Act, 1986 (29 of 1986) and Government of India, Ministry of Home Affairs Notification No. S.O. 667 (E) dated 10/9/1992, as required under sub-rule (3) of rule 6 of the Environment (Protection) Rules,

1986 is hereby pleased to amend the notification No. PCC/DMN/13-(Part-IV)/98-99/2014-15/1199 dated 9/10/2015 and No. PCC/DMN/13-(Part IV)/98-99/2014-15/1200 dated 9/10/2015 as below;

Item no. 2 of Preamble of Category-I and Item no. 2 of NOTE of Category-I : to be read as follows :

"All the industries falling under Category-I, EXCEPT those marked with "#", are Banned (Establishment) in the Union Territory of Daman, Diu and Dadra Nagar Haveli due to their high pollution potential/manufacturing processes/products which may endanger public health, safety and environment". Any application for expansion/modernization shall be considered on case to case basis in compliance of various norms of Pollution Control Committee, Central Pollution Control Board and MoEF & CC, New Delhi in non-ecologically sensitive areas.
