- 2. The Fishermen Associations shall use the jetty constructed towards Vadisheri to Tungano mor for ONHARD as per seniority of their registration nos. and lists given from the Fisheries and Port Department only. This is applicable to all boats of all Associations as a whole. Seniority within the associations shall not be considered.
- 3. Person or President of Crane Association cannot refuse to give Crane for "On Hard" to any Owners/Associations of Boat. However, the space for the operation of the crane must be found to be proper. If it is found improper, the Crane can be stopped from plying on jetty, as the jetty is government property.
- 4. The fees to be charged from non-members of the crane association for operating of Crane for ONHARD of Fishing Boats shall not exceed two times the charges taken from the members of the crane association.
- 5. The Fishermen Association and Crane operator have to ensure to keep space for plying of Fire Tender, specially behind Fishermen's Fuel pump beaching Platform, Vadisheri towards Northern side of fishermen shed jetty platform and "Tunganomor" jetty platform.
- 6. The concerned Crane Associations/Fishermen Associations shall be fully responsible for the security of the fishing boats, public, etc. and Govt. will not be responsible for any accident, loss and damage from theft, fire, water, cyclone, electric failure or any other cause whatsoever.
- 7. The payment for operation of the Crane on Jetty Platform within Port Vicinity shall pay in advance as required under Port Rules inforce @ Rs. 75/- per month in Port Office, Diu, by the concerned Crane Association.
- 8. The Crane operator/Agent/Boat Owners shall ensure that no damages to the jetty platform, government property, etc take place. If it does take place, the cost for the repairs shall be recovered from the concerned crane association.
- 9. There should not any type of temporary of permanent construction within Port vicinity and it should be kept clean.
- 10. No refuge, oil, grease, etc. shall be thrown in the sea or creek water or on jetty platform.
- 11. The Boat Owner shall have to pay ONHARD fees in Port Office, Diu.
- 12. There shall not be any obstruction in present fishing activity due to ONHARD of fishing Boats.
- 13. The Crane Associations have to ensure that no any political gathering, samiyana, etc shall be erected on the jetty platform without approval of competent authority.

14. Violation of above mentioned conditions will be punishable by the government as per the extant rules and regulations. It may also lead to cancellation of any kind of permission issued to the concerned boat owner/crane operator/fishermen association, etc.
