- 1. Review the Social Impact Assessment Team report and find out whether the land acquisition project serves any public purpose or not.
- Find out whether the potential benefits outweigh the social costs and adverse social impacts of land acquisition.
- 3. Give recommendation within two months from the date of its constitution whether the extent of land proposed to be acquired is the absolute bare-minimum extent needed for the project and whether there are no other less displacing option available. It is also provided that the grounds for such recommendation shall be recorded in writing by the Expert Group giving the details and reasons for such decision.
- 4. As per the (RFCTLARR) Act, 2013 the recommendation shall be made available in the local language to the Panchayat or Municipal Council, and District Collector Office and shall be published on the website of the appropriate Govt.
