<u>Annexure - I</u> Indicates Holidays in the Union Territory of Daman & Diu during the calendar year 2019, Saka 1940-41 which shall apply to all Government Offices/Semi Govt. Offices/Local Bodies/Commercial Banks in Daman & Diu.

Annexure - II Indicates the list of Restricted Holidays out of which an employee is entitled to avail any two holidays.

Annexure — III Indicates Holidays under the Negotiable Instruments Act, 1881 which apply to all the Industrial Establishment, Public Sector Undertaking and Commercial Banks operating in Union Territory of Daman & Diu. The Commercial Banks operating in Union Territory of Daman shall observe holidays declared by respective regional offices according to their norms. However, State Bank of India, Daman and State Bank of India, Diu in which Government trasaction is being done, shall have to observe the holidays—specified in the Annexure—I and the Government transaction / RBI chest will remain operative on other working days.
