### OFFICE MEMORANDUM

Subject: Issuance of Income and Asset Certificate to the Economically Weaker Sections (EWS) in the UT of Daman & Diu and Dadra & Nagar Haveli.

Reference is invited to O. M. No. 36039/1/2019-Estt (Res) dated 31.01.2019 of DoPT, Govt. of India on the above cited subject.

As the work related to issuance of Income and Asset Certificate to economically weaker section for providing reservation in the direct recruitment in civil posts and services in Government of India comes under the domain of Revenue Department, appropriate action relating to issuance of Income and Asset Certificate and their verification etc. may be issued by the Revenue Department.

In the cited DoPT OM, the criteria of Income and Asset Certificate is stipulated as under:

- A. The Income and Asset Certificate shall be issued to the persons belonging to EWS who are not covered under any of the existing schemes of reservation for SCs/STs/OBCs (States/ UTs & Central list).
- B. Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8 00 lakh (Rupees Eight Lakh Only) are to be identified as EWS for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.
- C. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:
  - 5 Acres of Agricultural land and above;
  - ii. Residential flat of 1000 sq. ft, and above;
  - iii. Residential Plot of 100 sq. yards and above in notified municipalities.
  - iv. Residential Plot of 200 sq. yards and above in areas other than the notified municipalities.

- D. The property held by a "Family" in different locations or different places/ cities would be clubbed while applying the land or property holding test to determine EWS status.
- E. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/ her parents and siblings below the age of 18 years as also his/ her spouse and children below the age of 18 years.

Based on the above cited DoPT OM, and keeping in view the prevailing circumstances in the UT of Daman & Diu/ Dadra & Nagar Haveli, following set of guidelines/ process/ Instructions for issuance of Income and Asset Certificate for the EWS category is issued:

- The concerned Mamlatdar shall be the Issuing Authority in respect of Income and Assets Certificate of EWS Category in the UT of Daman & Diu/ Dadra & Nagar Haveli.
- 2. The issuing Officer i.e. Mamlatdar would issue the Income and Assets Certificate after carefully verifying all relevant documents, in the format placed at Annexure-I.
- 3. Applicants applying for obtaining Income and Assets Certificate under EWS category shall apply in prescribed application form placed at Annexure-II.
- 4. The applicant shall attach all the requisite documents as listed in the list of documents required for the issuance of the certificate stipulated in application form.
- 5. The Income and Assets Certificate under EWS shall be issued by the Issuing Authority only after his complete satisfaction of the supporting facts/information submitted and due verification of such supporting facts/documents by the applicant.
- The Income and Assets Certificate under EWS shall be issued within 15
  working days from the date of receipt of application form duly completed in all
  respect to the satisfaction of the Issuing Authority.
- 7. The Issuing Authority shall examine the requisite information/ facts provided by the applicant qua the eligibility criteria and satisfy himself that the applicant is eligible in all respects for obtaining Income and Assets Certificate under

EWS category as prescribed by Gol vide O. M. dated 31.01.2019 as aforesaid.

- 8. It is relevant to mention here that in case of obtaining Income and Assets Certificate under EWS category by any applicant by furnishing incorrect, false and fraudulent information in the application/ documents furnished for issuing the certificate, proceeding may be initiated against him under the relevant Sections of Law.
- 9. It is also noteworthy that in case the Income and Assets Certificate under EWS category is issued by the Issuing Authority without due diligence qua the fulfilment of criterion prescribed as cited above and without following the procedure prescribed herein, action under relevant conduct rules i.e. CCS, CCA Rules 1965 may be initiated against such erring issuing authorities.
- 10. It is further emphasized that the Income and Assets Certificate for EWS Category may only be issued in accordance with the prescribed criteria by the Government of India as per the aforesaid DoPT O.M. dated 31.01.2019. However, in case it is noticed that a certificate has been obtained by any applicant on the basis of false & Fraudulent facts/ information, the Sub-Divisional Magistrate shall cancel such certificate with immediate effect and an intimation thereof shall be sent to the applicant and also to his employer if it is known to the Sub-Divisional Magistrate concerned that the said certificate had been submitted before any employer by such applicant. Any person aggrieved by the cancellation order may file an appeal with the District Magistrate.
- 11. The Income and Assets Certificate under EWS shall be issued on the basis of Income from all sources pertaining to the financial year prior to the year of filing the application. It implies that for making such applications by an applicant during a financial year he has to provide family Income details pertaining to previous financial year but details of Immovable Property details shall be as on the date application is being filed before the certificate Issuing Authority and it also implies that a Income and Assets Certificate under EWS issued shall be valid only for the financial year in which it has been issued. To illustrate by an example; If an application filed in the month of May, 2019, the

same will be issued on the basis of income for the financial year 2018-19 and the certificate shall remain valid only till 31<sup>st</sup> March 2020.

12. Further, for Income and Assets Certificate under EWS with effect from the financial year 2020-21 and onwards it would be necessary for the applicants to fill up the details of the Income and Assets Certificate under EWS category obtained in earlier years in the application form for the period starting from financial year 2019-20 and onwards.

This issues with the prior approval of the competent authority.
