ORDER

Whereas, the UT Administration of Daman & Diu, vide Notification No. BDO/DMN/GPSPL/2019/593 dated 29/07/2019, has excluded certain Panchayat areas from the territorial jurisdiction of Dabhel Gram Sabha/Gram Panchayat, and constituted separate three new Gram Panchayats namely (1) Ghelwad Gram Panchayat, (2) Somnath Gram Panchayat and (3) Antiawad Gram Panchayat;

And whereas, as a consequence to the aforesaid Notification dated 29/07/2019, following eleven Members & Sarpanch of Gram Panchayat Dabhel have ceased to be members / Sarpanch of Gram Sabha / Gram Panchayat, Dabhel under clause (d) of section 4 read with sub-section (1) of section 7 of the Daman and Diu Panchayat Regulation, 2012;

And whereas, in view of the above, effective strength of elected members of Gram Panchayat Dabhel got reduced to only 3 (three) members, which is not in conformity with sub-section (2) of section 12 of the said Regulation;

And whereas, notices were served under sub-section (2) of section 51 of the Daman & Diu Panchayat Regulation 2012, to the following three remaining members giving them opportunity to show cause as to why the Gram Panchayat Dabhel should not be dissolved;

And whereas, in response to the same, all the above three Members of Dabhel Gram Panchayat vide their letters dated 02/08/2019 have tendered their resignation as Member of Dabhel Gram Panchayat;

And whereas, Section 51 (b) of the Daman and Diu Panchayat Regulation, 2012 states that if in the opinion of the Administrator, a Gram Panchayaty is incompetent to perform or makes willful and persistent default in the performance of the duties imposed on it by or under this Regulation or any other law for the time being in force, he may, by order published in the Official Gazette, dissolve the Gram Panchayat;

And whereas, in view of the above facts, the Administrator of UT of Daman & Diu is of the opinion that the Dabhel Gram Panchayat is incompetent to perform its duties in view of clause (b) of sub-section (1) of section 51 read with sub-section (2) of section 12 of the Daman and Diu Panchayat Regulation 2012, as Sarpanch and 11 members have ceased to hold office and remaining three members have submitted their resignation, and hence, has rendered itself liable for dissolution under sub-section (1) of section 51;

Now therefore, the Administrator of UT of Daman & Diu, in exercise of powers conferred upon him, under sub-section (1) of section 51 of the Daman & Diu Panchayat Regulation 2012, hereby dissolves Gram Panchayat Dabhel, with immediate effect.
