In exercise of powers vested to him, the Administrator, U.T. of Daman and Diu is hereby pleased to implement plan scheme namely "Replacement of kerosene driven OBM engine by LPG driven OBM engine (8-10 HP) of small fishing traditional boat owners of Daman & Diu in U.T. of Daman and Diu" from the financial year 2013-14 for the welfare of fisherman with effect from date of publication of the same in official Gazette of U.T. of Daman and Diu.

The details of the scheme are as follows:

**Objective and Activities:** Protect the kerosene driven traditional fisherman those are operating OBM engine (8-10 HP)

**Justification :** The shortage and unavailability of kerosene in open market, fisherman are facing hardship to continue their traditional fishing business by kerosene driven OBM (8-10 HP).

Therefore, to solve this problem LPG operated OBM engine (8-10 HP) shall be provided in place of kerosene driven OBM engine to the registered small and marginal boat owners of Daman and Diu only.

## Pattern of Assistance:

- One time back ended subsidy @ 75% maximum ceiling upto Rs.1.20 Lakhs subject to verification of installation & operationalization of engine by fisheries Department.
- Remaining 25% or above shall be borne by beneficiaries operating OBM engine  $(8-10\ HP)$ .
