### AWARD

(Passed in open court on 22<sup>nd</sup> December, 2011)

- This is the reference made vide letter No. LE/LI/DMN/FACAT-4(7)/2003/366, made by the Asst. Secretary (Labour & Emp.), Daman under Sec. 10 (1) of the Industrial Disputes Act in respect of an industrial dispute between M/s Hindustan Lever Limited, and its workman Shri Bharat N. Patel in respect of matters (1) Whether the employer is competent to direct the suspended employee to mark his attendance regularly for the purpose of subsistence allowance.
- 2] The IInd party Workman files statement of claim of statement at Exh. 7 on 30/01/2004.
- On the other hand Ist party filed written statement strongly opposing the claim of second party and contended that no relief can be granted in favour of Second Party workman as the workmen has already terminated after following due process of law and application under section 32(2) (b) of the said Act has already been preferred by the first party before competent court which is pending.
