Whereas, the Commission had approved the schedule of special summary revision of electoral rolls with reference to 01.01.2014 as the qualifying date for the U.T. of Daman & Diu vide its letter No. 23/D&D/2014 dated 8th August, 2013 providing inter-alia, 2nd September, 2013 as the date of draft publication. The period for filing of claims and objections was fixed from 2nd September, 2013 (Monday) to 1st October, 2013 (Tuesday).
