#### **NOTIFICATION**

In exercise of the powers conferred under section 10 (i) (b) of National Food Security Act, 2013 (No. 20 of 2013), the Administrator of Union Territory of Daman & Diu hereby frames the following draft guidelines for identification of priority households for the purposes of the said Act. The objections and suggestions in the matter may be submitted within 30 days to the Secretary (Food & Civil Supply) Daman & Diu.

### <u>Criteria for eligible households under the National Food Security Act, 2013 in the U.T. of Daman & Diu.</u>

Priority households shall be those households which quality on both (1) Inclusion Criteria, and (2) Exclusion Criteria.

- **1. INCLUSION CRITERIA** :- Following Category of people will be included under priority households:-
  - 1. All the Below Poverty Line households.
  - 2. Socially and Occupationally Vulnerable Groups :-
  - I. All homeless households.
  - II. All households headed by a single woman (Unmarried/separated/deserted).
  - III. All Scheduled Tribes households.
  - IV. All Scheduled Castes households.
  - All households of landless Agricultural laborers.
  - VI. All households of farmers and owning land up to 2.00 acres in the U.T. of Daman & Diu.
  - VII. All households headed by a person registered as an unorganized labour under the provisions of the Unorganized Worker's Social Security Act, 2008 (33 of 2008);
  - VIII. And households of all other Occupationally vulnerable groups like Fishermen, Rag-Pickers unskilled construction workers, porters, casual daily wage labourers, casual domestic labourers, cycle rickshaw drivers, unskilled workers in small households enterprises, unskilled workers in household industries, Sweepers/Sanitation workers, disabled persons.
  - IX. Transgender.
  - 3. All households living in Kutcha houses.
  - 4. All other households having annual income less than Rs. 1,00,000/-

**EXCLUSION CRITERIA** :- Following Categories of households will be automatically excluded from the ambit of priority households :-

- 1. Households having an income tax payer.
- 2. Households where any member is an owner/partner of a firm which is registered under VAT.
- 3. If any member of a household owns a light motor vehicle (Four Wheeler) or heavy vehicle, except maximum one commercial vehicle for earning livelihoods.
- 4. All employees (other than contractual/work charged/daily wagers) of Government of India, State Governments and Union Territories or its boards/corporations/enterprises/undertaking, other Autonomous bodies/ Authorities such as college, Municipal Councils, etc.
- 5. Such other households, which may be excluded as per criteria, as may be prescribed by the Administration.

#### Declaration of VDA under the Minimum Wages Act, 1948.

In addition to the Basis Pay Fixed by the Administration of Daman & Diu in respect of all the scheduled employments under the Minimum Wages Act, 1948 vide notification No. LE/LI/DMN/MWA-3(II)/2011/594 dated 21/09/2011, the daily rate of VDA payable on the cost of living index number is increased at the rate of  $\stackrel{?}{\phantom{}}$  10.80/- with effect from 01/10/2013.

1.	Every employment in the schedule to the Minimum Wages Act, 1948. (Part I & Part II)	81.20/-

Thus the minimum rates of wages payable in respect of all the employments in the Schedule to the Minimum Wages Act, 1948 in the Union Territory of Daman and Diu is as under:

#### Minimum rates of wages payable per day

Category	Basic	VDA	Total
Skilled	128	81.20	209.20
Semi-Skilled	121.50	81.20	202.70
Un-Skilled	115	81.20	196.20

**Note:** For monthly wages, multiply with 26 days.

#### **NOTIFICATION**

In compliance of the direction of the Hon'ble Supreme Court in WP (CRL) 129 of 2006 (Laxmi V/s. Union of India and others) regarding compensation to victims of acid attack, the entry at Serial No. 10 to the schedule annexed to para 12 of the Union Territory of Daman & Diu Victim Assistance Scheme 2012, is hereby amended as follows:

Sr. No.		Minimum Limit (In ₹)	Maximum Limit of Assistance (In ₹)
10	Victim of acid attack :	Compensation of at least ₹ 3,00,000/- (Rupees Three Lakh) shall be paid to said attack victims as the after care and rehabilitation cost. Of this amount :-	₹ 4 lakh
		(a) A sum of ₹ 1 lakh shall be paid within 15 days on the occurrence of such incidence (or bring brought to the notice of the UT Administration of Daman & Diu) to facilitate immediate medical attention and expenses in this regard.	
		(b) The balance sum of ₹ 2 lakhs shall be paid to the victims expeditiously as may be possible and positively within two months thereafter
