**DECLARATION**

WHEREAS, vide Preliminary Notification No. 3/14/2017/LQN/CG/2017/11928 dated 27/12/2017, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of proposed Road from Narayan Park to proposed Commercial Airport Terminal and parking / land scaping area of proposed Airport Terminal at Village Kathiria, Nani Daman.

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, objection were accorded personal hearing by the Collector, Daman on **04/04/ 2018**, and a report was submitted to the Government Authority i.e. Administration of Daman & Diu for the proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Daman & Diu.

AND WHEREAS, the UT Administration of Daman & Diu is satisfied, on the basis of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition process.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for the purpose of proposed Road from Narayan Park to proposed Commercial Airport Terminal and parking / land scaping area of proposed Airport Terminal at Village Kathiria, Nani Daman.
