## ORDER

In exercise of the power conferred by Section 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and Rule 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rule, 2014, the UT Administration of Daman & Diu hereby empanels the following Institutions/Agencies as "Social Impact Assessment (SIA) Team" to carry out Social Impact Assessment Studies to acquire land for any project in public interest.

- 1. Gujarat Environment Management Institute (GEMI),(An Autonomous Institute of Government of Gujarat), Block No.13, 3<sup>rd</sup> Floor, Dr. Jivraj Mehta Bhavan, Old Sachivalaya, Sector 10B, Gandhinagar-382010 (Gujarat).
- 2. SR Asia, 4F-CS-25, Ansal Plaza, Ghaziabad. UP-201010.

The Collector, Daman will ask for rate proposal from the empanelled organizations. On requisition of Collector for conducting SIA, empanelled SIA Teams shall submit to the Collector within a fortnight the Fees/Costs to be charged for such SIA study. This calculation shall be based upon the area and Sociological/geographical features of the area to be acquired. This will clearly indicate the expected no. of affected families and other factors that are considered as basis for calculating the fees for SIA study. Collector shall issue the work after analyzing the cost and the payment shall be made by Collector concerned after following the due procedure.

SIA study shall be conducted on the request of Collector and strictly in accordance with the provisions of the RFCTLARR Act, 2013 and RFCTLARR Rules, 2014. After conducting study, the SIA Team shall submit the required reports to the Collector as prescribed in the RFCTLARR Act, 2013 and RFCTLARR Rules, 2014.

If at any stage, SIA Team is unable to complete the SIA process and fails to prepare the SIA Report to SIMP due to incapacity or otherwise, the Collector shall debar the SIA Team after giving opportunity of being heard. It may allot the SIA study to another SIA Team as the case may be, to complete the Social Impact Assessment process.

UT Administration of Daman & Diu shall be Competent to disqualify and deempanel and SIA Unit any time after assigning a reasoned cause.
