## NOTICE

WHEREAS, vide Preliminary Notification No.3/56/2019/LND-ACQ/2018-19/2082 dated 12/09/2019, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely Acquisition of land for Upgradation and Expansion of Government Hospital at Marwad, Nani Daman.

WHEREAS, a report was submitted to the Government Authority i.e. Administration of Dadra & Nagar Haveli and Daman & Diu for the proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu, Daman.

WHEREAS, vide Declaration No.3/56/2019/LND-ACQ/2018-19/3616 dated 06/05/2020, it is declared under the provision of Section 19 of the Land Acquisition, Rehabilitation Act that the said lands are required for the public purpose, and namely for the purpose of Acquisition of land for Upgradation and Expansion of Government Hospital at Marwad, Nani Daman.

WHEREAS, in connection with acquisition of land admeasuring 12917.00 sq. mtrs. for construction of Acquisition of land for Upgradation and Expansion of Government Hospital at Marwad, Nani Daman, the Administration of Daman intends to take possession of the land, the particulars of which are given in the declaration u/s 19(1) of the Right to Fair compensation & Transparency in Land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.
