## **ORDER**

Subject :

Orders issued by Revenue Authorities against Government-furnishing of a copy of such order to Dy./ Joint Secretary (Revenue)-regarding

Instances have come to notice that the Revenue Officers, while exercising jurisdiction as Revenue Court under the Goa, Daman & Diu Land Revenue Code, 1968, the Daman (Abolition of Proprietorship of Villages) Regulation, 1962 etc. pronounce Judgment/Order against the Government, where the claim of Government over land is involved. However, a copy of such Judgment /Order is not being sent by the concerned Revenue Authorities to the Revenue Department for the decision of Government, whether to file an appeal against such Judgment/Order passed by the Revenue Authority. In absence of information of passing such Judgment/Order against Govt. interest, Revenue Department is unable to file appeal / revision against such Order /Judgment, leading to avoidable loss to Government.

- 2. In order to safeguard the Government interest in land, it is hereby directed that all the Revenue Officers, while exercising jurisdiction as Revenue Court under the Goa, Daman & Diu Land Revenue Code, 1968, the Daman (Abolition of Proprietorship of Villages) Regulation, 1962 etc. shall invariably, while deciding the case in which claim of Government is involved, send a copy of Judgment / Order to the Dy. Secretary / Jt. Secretary (Revenue), whether such Judgment /Order is in favour or against the Government.
- 3. The Dy. Secretary / Jt. Secretary (Revenue) shall on receiving such Judgment / Order from Revenue Courts, examine the Judgment/ Order on merit within fifteen days and take action to file an appeal, where such order /Judgment is against Government,

with the appropriate competent Court within time prescribed for filing an Appeal under the Goa, Daman & Diu Land Revenue code 1968, or the Daman (Abolition of Proprietorship of Villages) Regulation, 1962 etc. as the case may be, with the approval of Competent Authority. In case the Judgment is in favour of Government, the Dy. Secretary / Jt. Secretary (Revenue) shall ensure that necessary mutation to enter such Land in the name of Government in Record of Right is carried out promptly.

4. The above instruction shall be followed by all concerned Revenue Authorities scrupulously.
