8. The State/UT should fulfill all terms and conditions contained in the Scheme at the time of submitting the proposals. It may also be ensured that proposals are submitted along with Utilization Certificate in GFR-19 A.

9. The State Governments/UT Administrations are also advised to indicate to this Ministry, the status of disbursement of scholarships released in the year 2012-13. The State Governments/UT Administrations must upload on their respective websites, the detailed list of students who were given scholarship in the previous year so that the same could be hyperlinked with the website of this Ministry. **Failure to place the list of beneficiaries for the year 2012-13 may result in non-consideration of proposals.**


