Dear Madam,

As you are aware, this Ministry provides support in the form of financial grants every year to voluntary organizations running projects in the disability sector in your State under the Deendayal Disability Rehabilitation Scheme (DDRS). This is to request for proposals for grant in aid for **2012-13** under the scheme.

- 2. In this connection, it is informed that the notional allocation for the UTs of **Puducherry**, **Dadra & Nagar Haveli**, **Andaman & Nocobar Islands**, **Daman and Diu and Lakshdweep** under this scheme for the year 2012-13 has been fixed at **Rs.0.5 crore**. The notional allocation has been worked out on the basis of the committed as well as estimated liability of all the ongoing proposals of the above UTs.
- 3. Proposals from voluntary organizations for grants-in-aid for 2012-13 under DDRS, duly recommended and prioritized by the Multi-disciplinary grant-in-aid Committee (GIA Committee) of your State are to be forwarded to this Ministry in a consolidated manner within the notional allocation indicated above. The signed minutes of the meeting of the GIA Committee and the proposals in the prescribed format, indicating the inter se priority, should be sent latest by 30<sup>th</sup> June, 2012.
- 4. As per the policy, the 'ongoing' cases i.e. NGOs receiving grants during previous years are to be given priority and, therefore, you are requested to consider such type of cases first and recommend them on their suitability to receive the grant, if their performance is satisfactory

5. Some of the important instructions relating to 'on going cases' and 'new cases' issued from time to time for consideration of grant-in-aid are enclosed as **Annexure**, which may kindly be gone through and followed for facilitating expeditious processing of grant under DDRS.

- 6. As you are aware, the District Disability Rehabilitation Centre (DDRCs) are funded under SIPDA scheme for the first 3 years and 5 years in the case of North-Eastern States, J&K, and all UTs except Chandigarh & NCT of Delhi, and, thereafter under DDRS. Therefore, recommendation of proposals of DDRCs receiving funds under SIPDA or DDRS should be forwarded separately.
- 7. I shall be grateful if proposals under DDRS complete in all respect as explained above are sent positively by 30<sup>th</sup> June, 2012 to enable this Ministry to process the proposals expeditiously and further to release grant to the maximum of the allocation provided to your State/UT under the scheme.

# IMPORTANT INSTRUCTIONS ISSUED FROM TIME TO TIME FOR CONSIDERATION OF GRANT-IN-AID UNDER DDRS

### 'On going Cases'

> Original proposal duly ink-signed should be sent to the Ministry while the copy may be retained by the State Government;

Most of the columns of Inspection Report are not filled properly and in particular the column relating to number of beneficiaries found present at the time of inspection. Inspection Report in original and not photocopy should be sent.

> Attested copy of the valid PwD certificate for the period for which the proposal for grant is being considered.

- Funds are transferred directly into the bank accounts of the NGOs through E-mode. For this purpose, an authorization letter needs to be submitted along with the proposal which should be countersigned by the Branch Manager of the concerned bank. The NGO should ensure that they have their bank account in the bank branch having facility of electronic transfer of funds.
- > Audited statement of Accounts in respect of the concerned project consisting of:
  - (a) Balance-sheet;
  - (b) Receipt and payment account;
  - (c) Income and expenditure account;
  - (d) Item-wise and post-wise break-up of expenditure duly attested by the Chartered Accountant and the authorized signatory of the organization.
  - (e) CA membership No
- > Utilisation (UC) in respect of the grant received earlier in the prescribed format.
- > In the case of schools for children with special needs, inspection not to be conducted during the vacations/holidays.
- > Documents required are either not furnished along with the proposal or not furnished in the prescribed format thereby causing delay in release of funds. The list of documents as well as format are made available in the Ministry's website i.e. www.socialjustice.nic.in.

#### 'New Cases'

> New proposals recommended by the State GIA Committee should be forwarded to this Ministry only after the proposal and documents of the concerned NGOs are duly attested by the Gazetted Officer or notarized on each page.
