
Sub:- Regarding Utilisation of MPLADS funds for Persons with Disabilities – instructions thereof.

Secretary to Govt. of India, Ministry of Social Justice & Empowerment of Persons with Disabilities, vide his D.O. letter No. 4/9/2016-AIC dated 22.04.2016 (Copy enclosed as Annexure 'A'), addressed to Administrator of UT of Daman & Diu, has conveyed instructions on "Utilisation of MPLADS funds for Persons with Disabilities", mandated by Hon'ble Prime Minister of India while launching Accessible India Campaign (Sugamya Bharat Abhiyan) on 3<sup>rd</sup> December, 2015 on the occasion of International Day of Persons with Disabilities.

For the sake of clarity in implementing and achieving the desired targets of "Sugamya Bharat Abhiyan", the same instructions are circulated herewith to all the departments/agencies under the Administrative control of UT Administration of Daman & Diu to ensure that durable" assets, being created under MPLADS, which includes all accessibility features, are accessible for Persons with Disabilities and instructions of Ministry of Statistics & Programme implementation, issued vide letter F.No. C-14/2013-MPLADS dated 15.01.2016 (Copy enclosed as Annexure 'B'), may be used for ensuring accessibility to the extent possible in durable and moveable assets created in your department/agency".

As you are aware, the Department of Empowerment of Persons with Disabilities (DEPwD), Ministry of Social Justice & Empowerment (MoSJ&E) launched the Accessible India Campaign (Sugamya Bharat Abhiyan) on 3<sup>rd</sup> December, 2015, on the occasion of International Day for Persons with Disabilities, as a nation-wide flagship campaign for achieving universal accessibility for persons with disabilities and to create an enabling and barrier-free environment. This is an extremely important Campaign to ensure that the physical infrastructure, both in public and private sector is accessible for persons with disabilities, so that they can participate with full dignity and freedom in all social and economic activities of the society.

2. The Campaign has specific targets for making 2500 government buildings across various States, 705 railway stations, all international airports, accessible in a given timeframe apart from creating accessibility in transport system and Information & Communication Technology (ICT) eco-system.

3. For creating accessibility in suburban and rural areas, on the request of DEPwD, Ministry of Statistics & Programme Implementation, Govt. of India has issued instructions (copy enclosed) to all the State Govts. with copies to all the District Magistrates and District Collectors that in future, it will be mandatory that the durable assets created under the Member of Parliament Local Area Development Scheme (MPLADS) are friendly to persons with disabilities, wherever feasible. Retrofitting in existing durable assets created under MPLADS to make them friendly to persons with disabilities will also be permissible.

4. The same instructions mentioned that it has also been decided that in future all movable assets specifically permissible under the Guidelines on MPLADS such as school buses, ambulances, mobile dispensaries, etc. procured with MPLADS funds are friendly to persons with disabilities, wherever feasible.
