PRESS-NOTE

On the Eve of New Year, celebrations are being organized at various places in Daman. This year also 31st December, 2016 in view of the said celebrations, all the Hoteliers, Bar and Restaurant Owners are directed to strictly adhere to the following instruction and guidelines.

- 1. All the Hotel owners and Bar and Restaurant Owners are directed to restrict their Guests within their premises and should under no circumstances allow them to go out on the open street or road in inebriated state.
- 2. The celebration should be confined to the Hotel/Bar/Restaurant premises only. For running orchestra/musical evening, temporary permission shall be taken from the office of Collector/District Magistrate well in advance, failing which, Police will be taking appropriate action for creating nuisance in terms of noise/Sound Pollution.
- 3. No liquor should be served outside the licensed premises.
- 4. All Bars and Restaurants who have obtained special permission should be closed by 02-00 hours of 1st January,2017 and others by normal closing hours i.e. 11.00 p.m. on 31/12/2016.
- 5. Each Hotel must set up "Lost and Found Counter" along with public Address System (PAS) and bring any information regarding loss of any property immediately to the knowledge of the public through the PAS. In case nobody claims the lost property, information may immediately be sent to the Police Control Room (Telephone No. 2220102/2220444).
- 6. All unclaimed property should be sent to the Police Station by 04.00 p.m. on 01/01/2017.
- 7. No vehicle should be allowed to enter the No Parking Zone or go anywhere near the beaches.
- 8. No vehicle will ply in "Restricted Zone" without vehicle Pass issued by the Sub Divisional Police Officer, Daman, Passes may be collected by 06.00 p.m. on 29/12/2016 from the office of Sub Divisional Police Officer, Daman.
- 9. Full Assistance should be provided to the Government Officers on duty in maintaining Law & Order.
- 10. Failure to observe the above instructions shall lead to stringent penel action.
