ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE.

WHEREAS, The festival of Bakri Id is to be celebrated on 12/08/2019. It is a known fact that Qurbani/Slaughter of permissible animals is undertaken during the festival.

WHEREAS, there is an apprehension that slaughter of animals in public/open place may lead to disturbance of Law & Order in Daman District.

WHEREAS, for celebrating the occasion in peaceful manner, maintaining Law & Order & public tranquility, it is necessary that the ritual of Slaughter/ Qurbani be regulated.

THEREFORE, in exercise of the powers under section 144 of code of Criminal Procedure 1973, (No.2 of 1974) I, Rakesh Minhas, IAS, District Magistrate, Daman, hereby order that Slaughter/ Qurbani of permissible animals will only be allowed in Government approved slaughter house. No Qurbani shall be performed at any Open/Public place on 12/08/2019 or days following the Bakri Id in Daman district. It is also ordered that the entire administrative machinery and all the religious organizations and other associations shall work towards maintaining Law & Order during the festival.

This order shall come into force with immediate effect for a period of 03 days from 12/08/2019 to 14/08/2019 (both days inclusive) unless withdrawn earlier.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.



As the notice cannot be served individually on all concerned, the order is hereby passed ex-parte. It shall be published for the information of the public through Press and by affixing copies on the notice board of administrative office including every police station, police outposts, SP Office, SDPO Office, and the offices of the Municipal Council and District Panchayat of Daman.
