#### ORDER (u/s 133 Cr.PC, 1973)

WHEREAS, in the wake of outbreak of Avian influenza or Bird Flu, this Office vide Order dated 11/01/2021, referred in preamble (1), had banned the entry of all poultry and non-poultry birds from all the States, closed down the poultry shops frozen poultry items and advised all Hotels to refrain consumption or sale/purchase of chicken related dishes in order to contain the spread of Avian Influenza or Bird Flu;

AND WHEREAS, the Department of Animal Husbandry & Veterinary Services, Daman, reported to this Office that Avian Influenza is a virus that infects only birds and not human beings;

AND WHEREAS, it was also reported that the said virus destroyed at 70 degree centigrade within 3 seconds and thus, consumption of meal and egg properly cooked at 70 degree has no risk;

AND WHEREAS, it was further reported that selling of poultry products sourced from the non-infected areas/states etc may be allowed and also, no positive cases have been reported in the District of Daman:

THEREFORE, in view of above and in exercise of the powers conferred under Section 133 of the Code of Criminal Procedure, 1973, I, Dr. Rakesh Minhas, District Magistrate, Daman, hereby revoke the Order dated 11/01/2021, referred in preamble (1).

# ORDER UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE.

THEREFORE, in exercise of the powers under section 144 of code of Criminal Procedure 1973, (No.2 of 1974) I, Rakesh Minhas, IAS, District Magistrate, Daman hereby order that no private motorised vehicles shall not be allowed in the campus of Institute of Our Lady of Fatima, Fort Area, Moti Daman during the School hours.

This order shall come into force with immediate effect till further orders.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.
