**REPORT**

Under section 8 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

This is about a proposal received from the Executive Engineer, Public Work Department, WD-I, Daman for acquisition of land admeasuring 300.00 Sq. Mtrs. at Village Bhimpore, Nani Daman for Acquisition of Land for Widening of Road at Village Bhimpore, Nani Daman.

The Administration of Dadra and Nagar Haveli & Daman & Diu have appointed Gujarat Environment Management Institute (GEMI), Gujarat, Gandhingar of Social Impact Assessment vide Order No. COL-DMN/LA-SIA/122/Vol-I/2021/472 dated 16/02/222 to process as per rule 7 and submit final Social Impact Assessment report with Social Impact Management Plan in Form II.

The report of the Social Impact Assessment Team is as under:

The SIA team concluded that the process of land acquisition has both positive as well as adverse impacts. But the positives impacts of this project outweigh the negative ones. Keeping the overall scenario in view, it is found that the proposed Acquisition of Land for Widening of Road at Village Bhimpore, Nani Daman would benefit the local community and society at large.

The constitution of the Independent Multi-Disciplinary expert Group under section 7(1) of the act was notified vide No.5/2/COL/LAND/RECTLARR/2017-18/2885 dated 07/09/2020 for Appraisal of Social Impact Assessment report.

The appraisal report has been submitted by the expert committee on review of the SIA and SIMP Report for Acquisition of Land for Widening of Road at Village Bhimpore, Nani Daman vide Appraisal Report dated 15.09.2022 is as under:

- 1. The acquisition of land and properties has been necessitated to provide more basic amenities to the local people.
- 2. The estimated number of family being affected is about 1 Private land.


**Recommendations and Observations of the Committee are as under:**


