**CIRCULAR**

Sub:- Amendment in CCS(Pension) Rules, 1972.

The Government of India, Ministry of Personnel, P.G. and Pensions, Department of Pension and Pensioner's Welfare, New Delhi forwarded a copy of Notification on the Amendment to the CCS (Pension) Rules, 1972 vide letter No.1/19/2013-P&PW (E) dated 20.02.2014. A copy of the said letter dated 20.02.2014 along with all enclosures is attached here.


The Government of India has revised many forms under the CCS (Pension) Rules, 1972 by the Notification No.1/19/2013-P&PW (E) dated 20.02.2014. Copies of forms revised are attached with the said Notification.

It has noticed that many Heads of Offices/Drawing Officers in Daman and Diu are still using the old forms for submission of pension cases to offices of the Director of Accounts at Daman and Diu.

All the Heads of Offices/Drawing & Disbursing Officers of the UT of Daman & Diu are requested to use the revised forms henceforth for the pension cases of their employees. It is also requested to give wide publicity to these forms and instruct concerned employee/authority to use these revised forms.

It may please be noted that the Directorate of Accounts henceforth will accept pension proposals in the revised forms only and the proposals received in the old forms will be returned to the concerned HO/DDO. The Concerned Head of Office/Drawing & Disbursing Officer will be responsible for delay in settlement of pension case/retirement benefits of the retired Government Servant/Pensioner.
