CONDITIONS FOR SCHOLARSHIP:

1. The students must have achieved not less than 50% marks in the previous final Examination.
2. The annual Income of the Parents/Guardian, from all Income sources should not exceed Rs.2 lakh per year.

It may kindly be noted by all the applicants and the same may be brought to the notice of the Public in the General, that the Online Scholarship Management (OSMS) has been introduced from the year 2012-13. This site is accessed through the URL www.momascholarship.gov.in. A link to the site is also made available in the website of Ministry www.minorityaffairs.gov.in. It is reiterated that only online applications under Post Matric Scholarship scheme will be accepted from this year and no request for accepting offline applications will be entertained.

All the applicants are advised to take a print-out of the filled-in-application forms through OSMS, and to submit the same alongwith all supporting documents through their respective institute to the Dy. Director of Education, Daman and Education Officer, Diu. It may also be noted that without receipt of hard copy in the District, State/UT Department, the application is likely to be rejected.

Attention of the students is also invited that the FAQs available on the homepage of the website for filling up of online application. Please ensure that Bank Account and Aadhar Number of the Student should be complete and accurate, failing which the application form is likely to be rejected.

Last date for submission of Online Application is 15th September,2014 and last date of renewal case is 10th October,2024. Last date of duly signed printed version of Online Application to Department through respective institutes for fresh case & renewal case is 25th September,2014 & 20th October,2014 respectively.
