TERMS AND CONDITION:

1. The auction of above vehicles will be 'AS IS WHERE IS BASIS' and interested party can inspect the vehicles on working days during office hours after obtaining permission from the Assistant Director of Education, Nani Daman.
2. The bidder must submit a copy of their PAN Card Number, residential proof i.e. Ration Card, Voter ID card etc. without it will not be entertain.
3. The interested bidder shall have to deposit a token amount of Rs. 2,000/- (Rupees Two thousand only) at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to pay deposit 25% of the offered bid on the spot.
4. The bidder will start with the upset price as shown in the auction Notice.
5. The eligible participate will offer bid in the round-up of Rs. 100/- for above upset price.
6. An offer will be considered as highest and final only if the amount offered by the bidder is announced consequently three times uninterrupted.

7. The successful highest bidder will have to lift the vehicle upon the payment of full amount as per his bid within ten days from the date of issue of letter accepting his/their highest bid amount from the date of finalization of the auction by submitting documentary evidence in support of residential status (Ration Card/voters Identity card in case of individual and Registration Certificate in case of firms ect.)
8. The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse of his part in this regard.
9. Incase of failure of the highest bidder to deposit the amount of 25% on the total amount of his/their bid the deposit as made for security eligibility to participate in the auction will stand confiscated to the Govt.
10. Incase of the failure of the highest bidder (s) to lift the entire quantity of the relevant materials i.e. vehicle within the given period the amount of 25% of the total amount as per his/their bid will be confiscated.
11. Further the amount to be deposited/paid as per condition No.7 & 9 above will be adjusted according to the actual number quantity of relevant materials and the amount of Rs. 2,000/- as deposited under condition (5) above will be adjusted against demand under condition No.10.
12. Power to accept or reject the highest bid without assigning any reasons is reserved by the Asstt. Director of Education, Moti Daman.
13. The decision to accept/reject any/highest bid(s) will be communicated within 60 days from the date of auction.
