ORDER

In pursuance of the General Lok Sabha Election 2014, it is desirable to curtail/restrict the movement of liquor in the Union Territory of Daman & Diu and therefore all the manufacturers/wholesalers/retailers/Bar & Restaurants including hotels are hereby directed to maintain true accounts of purchase and sale of liquor/beer made by them on day to day basis as per the provisions of Excise Duty Act and Rules.

All the above mentioned licensee are required to keep their account up dated and it shall be made available to the inspecting authority at any time on their licensed premises of sale and also at the storage.

They are further directed to transport liquor with valid transport permit only issued by the concerned Excise Officials and the transport permit should contain the following information.

- 1. The kind of liquor with total quantity mentioned with batch number and number of boxes with size of bottles.
- 2. The vehicle number of the vehicle used for transportation of liquor.
- 3. Name of the driver with proper identification alongwith other staff.
- 4. Route/Road used for transportation within the district.

The manufacturers i.e. distilleries/breweries and all the wholesalers are further directed to submit daily report showing therein the opening and closing balance of the stock in their possession on day to day basis without fail.

All the distilleries who are obtaining export permits for export of liquor to other states and overseas are required to submit applications with the vehicle number in which goods will be exported and name of driver with mobile number.

The licensee are also directed to obtain transport permits from the concerned Excise Officials between 10.00 a.m. to 4.00 p.m. only. No transport permits will be issued after the above prescribed hours in any circumastances.

The transportation of liquor will be carried out with valid transport permit only upto 6.00 p.m. in the evening and the vehicles under transportation of liquor found after 6.00 p.m. will be detained and action will be taken to confiscate the total quantity of liquor without assigning any reason.

This is issued for strict compliance with immediate effect.
