#### NOTIFICATION

In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Department of Personnel and Training O.M. No. AB.14017/61/2008 – Esstt. (RR) dated 24<sup>th</sup> March, 2009, the Administrator of Daman & Diu and Dadra & Nagar Haveli is placed to make the following Rules relating to recruitment to the General Central Service Group 'C' (Non – Ministerial), (Non – Gazetted) post of **Sub Inspector of Excise** in Excise Department, Daman under the Administration of Daman and Diu, namely:

#### 1. Short title and commencement:

- (i) These rules may be called Administration of Daman & Diu, Excise Department, General Central Service Group 'C' (Non – Ministerial), (Non Gazetted) posts Recruitment Rules, 2016.
- (ii) They shall apply to the posts specified in Column 1 of the Schedule to these Rules.
- (iii) These rules will come into effect from the date of publication of this notification in the official Gazette and will relate to appointment to the various posts made on or after this date.

#### 2. Number of post, classification and scale of pay:

The number of posts, its classification of the said posts and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the said schedule annexed to these rules. Provided that, the Administrator of Daman & Diu may vary the no. of posts in column 1 of the said schedule from time subject to exigencies of work.

#### 3. Method of Recruitment, age limit, Qualification etc;

The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in column 6 to 13 of the aforesaid schedule.

#### 4. Disqualification: No person,

- a. Who has entered in to or contracted a marriage with a person having a spouse living, or
- b. Who, having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said posts. Provided, that the Administration of Daman & Diu may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other to the marriage and that there other grounds for so doing, exempt any person from the operation of this rule.

#### 5. Power to relax:

Where the Administration of Daman & Diu is of opinion that it is necessary or expedient so to do, it may be order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

#### 6 Saving:

Nothing in these rules shall effect reservation relaxation of age limit and other concession required to be provided for the Scheduled Castes and Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from the to time in this regard.

These rules are issued in super session of the existing Recruitment Rules for the posts.
