Madam,

This has reference to your application under reference above, this office in issuing "**No-Objection Certificate**" for transfer of Liquor License bearing No. RS/IMFL-CL/B&R/20 (Bar & Restaurant) from present business premises situated at House No. 8/309, Parkota Sheri, Moti Daman to new premises House No. 849/3, Survey No. 466/1 situated village Ambawadi, Moti Daman - 396 220.

The site abuts have single main road about 10 meters wide on south site of the premises.

In view of the above, so far as department is concerned, there would be no objection from the fire safety point of view for grant of "**No-Objection Certificate**" for transfer of Liquor License bearing No. RS/IMFL-CL/B&R/20 (Bar & Restaurant) from present business premises situated at House No. 8/309, Parkota Sheri, Moti Daman to new premises House No. 849/3, Survey No. 466/1 situated village Ambawadi, Moti Daman subject to satisfactory compliance with the basic fire fighting requirements of the National Building code of India and as required under the Notification No. DFS/DD/F.P.-Notification/2004-05/627 dated 12-01-2005 issued under sub-section (1) of section 13 of the Goa, Daman and Diu Fire Force Act, 1986.

1. First aid fire extinguishers bearing, ISI mark have installed in the premises and which shall be maintained periodically. So as to ensure their perfect serviceability at all times.
2. The storage, use and handing gasoline, fuel oil and other flammable liquid/gas shall not be permitted in Bar & Restaurant premises unless it complies with the regulations.
3. The particular employees shall be trained in the usage of Fire extinguishers and other Fire safety system in case of any emergency.
4. Any compartmentation in addition to the proposed plan/existing structure shall be made only prior approval of the fire department.

5. The eliminate fire hazards good housekeeping both inside and outside the building shall be strictly maintained by the occupants or the owner of the building.
6. It shall also be sole responsibility/duty of Management/Owner/ Occupant of the Liquor License/ Premises to maintain the entire arrangement of fire fighting system and equipment/accessories installed in the premises in good working condition so as to ensure their perfect serviceability at all time.
7. The applicant shall be required to obtain annually certificate for satisfactory maintenance of the fire fighting arrangement made in the premises before applying for annually renewal of Liquor License by the concerned authority failing which the same should be cancelled.
8. The competent authority shall renew the same only after the obtain annually satisfactory maintenance certificate from the fire department.
9. The applicant shall be required to submit the proposal to obtain annually certificate before a **month** from the date expired final No Objection Certificate.
10. The component authority reserves right to amend any additional recommendations deemed fir during final inspection or in future due to the protection of the company and employees.
11. Right to reject/withdrawn N.O.C at any time without any notice is vested/ reserved with the competent authority if the conditions stipulated above are not complied with.
12. This is issued for a period of one year only form the date of issue and subject renewed from time to time/annually failing which the same should be cancelled.

The applicant has paid the fire NOC fees to the tune of **Rs. 2500/- (Rupees Two Thousand Five Hundred Ninety Nine Only)** by Chalan No. 126 dated 14-03-2017.
