ORDER

As the Government Hospital, Daman has been notified for COVID-19 treatment facility for Daman district, the following Non-COVID facilities/services are hereby shifted to PHC, Kachigam and CHC, Moti Daman from Govt Hospital Daman.

- 1. Gynaecology and Paediatric Department will be shifted to Community Health Centre, Moti
 - ➤ Both Gynaecologists will attend to OPD and emergency duties at CHC, Moti Daman as per previously ordered time table.
 - > Paediatrician will attend to OPD and indoor duties at CHC, Moti Daman. NICU will continue to function at Government Hospital, Daman.
 - Gyneacologist not on emergency call will visit Government Hospital, Daman to see referred patients and any indoor cases.
 - Paediatrician will take rounds of NICU and indoor/ referred patients at Government Hospital. Daman. Visiting Paediatrician will attend CHC, Moti Daman as and when required.
- 2. Skin, Psychiatry, Dental, Ophthalmology and ENT Department will be shifted to PHC, Kachigam.
 - > All the specialists and doctors of above departments will attend to OPD and indoor duties at PHC, Kachigam.
 - > Patients for planned OT will be scheduled at Government Hospital, Daman so that surgery can be done without exposing patients to undue risk.
 - ENT & Eye Surgeon not on call will attend referred/ indoor patients at Government Hospital, Daman.
 - > Emergency duty time table for all specialists previously ordered will continue. Specialists will attend emergency call of Government Hospital, Daman, PHC and CHC.
- 3. Orthopaedids, General Surgery, General Medicine, ICU, NICU and Trauma Centre will continue at Government Hospital, Daman.
- 4. All doctors presently working in the various public health facilities will be re-delegated for COVID related duties, as and when required.

This order will come into force with immediate effect & until further orders.
