
O R D E R

The prisoners confined in Sub-Jail Diu of Diu District are transferred to Amreli District Jail, Government of Gujarat State with immediate effect, subject to the following conditions:

1. The concerned prisoners must adhere to the Gujarat State Prison Rules. Moreover, the rules of Jail Department of Gujarat State relating to jail security and safety shall be applicable.
2. The undertrial prisoners of Diu District Prison shall be produced before the local court through Video Conferencing System, as far as possible. In exceptional cases, they should be produced before the Court along with police escort party from Diu District. All such expenditure for this production shall be borne by the Daman & Diu Administration.
3. As per the provision of Jail Manual, the proposed expenditure on arrangement of security guards based at jail (salary of guarding staff, allowances etc.) shall also be reimbursed from the Daman & Diu Administration.
4. As per the daily expenditure relating to the prisoners (food, clothing, bedding, water and electricity and building repairing etc) Rs. 190/- per prisoners, i.e, Rs. 5700/- p.m. and looking to the wages allowances and expenditure of treatment, the applicable amount shall be recovered every month. There is possibility of variation in such expenditure looking to the average expenditure on food and other items. In the event of serious illness, if a Prisoner is referred to a hospital out of headquarter, the total expenditure shall be borne by the Daman & Diu Administration.
5. Payment will be made on the receipt of detailed monthly expenditure submitted to the Daman & Diu Administration by the Prisons Department, Government of Gujarat.

After following the above procedure, the prisoners shall be transferred to the Amreli District Jail immediately.
