CIRCULAR

In continuation to this Department's Circular referred at No. (ii) above, it was informed that Aadhaar number will be required for the purpose of establishing the identity of the deceased for the purpose of death registration w.e.f. 1st October, 14 2017.

However, the Ministry has informed that from the feedbacks received from various quarters and to avoid any inconvenience to the general public, it is to state that the interpretation / clarification of the above said Circular may be considered as follows:

" The notification prescribes that the applicant may provide Aadhaar number or Enrolment ID number of the deceased, if available and other details as sought in the application for the Death registration / certificate. In case, Aadhaar number of the deceased is not available, it will be sufficient to get a declaration to that effect from the applicant. Similarly, the applicant may also provide his own Aadhaar number and Aadhaar number of spouse and parents, if they are available, for establishing their identities. The requirement of Aadhaar number, therefore, is not mandatory".

All the Registration Authorities are requested to take note of the same and ensure compliance of the above given clarification.
