



C I R C U L A R

Subject: Inclusion of clause relating to five year free maintenance guarantee bond in tenders for road works.

1. Construction of Roads is being undertaken by PWD, OI DC and local bodies in the UT of Daman and Diu and Dadra and Nagar Haveli. It is important to ensure quality work in construction of roads.
2. PWD already has a provision in the conditions of contract requiring the Contractor to provide "free maintenance guarantee bond" for a period of five years from the date of completion. During this period the Contractor will be liable for repair of damaged portion of the B.T. surface of road and any structures i.e. cross drainage, masonry gutter etc. at his risk and cost and as directed by Engineer in charge. If the Roughness Index of B.T. surface during the maintenance period for "Five years period" is poorer than 4000 mm/km then agency would be liable for providing entire renewal coat with M.S.S. as per the direction and satisfaction of Engineer in charge. Total 5% of the tender Value shall be withheld as Security Deposit which will be released to the agency after the expiry of guarantee period (i.e. Five monsoon periods). During the above period, the contractor will have to provide the renewal coat with mix seal surfacing as per the direction and satisfaction of engineer in charge if "Black Top" surface is noticed as damaged or otherwise total 5% of the tender Value kept as Security Deposit will be forfeited.
3. All the autonomous bodies executing road works in UTs of Daman and Diu and Dadra and Nagar Haveli are hereby directed to ensure inclusion of above provisions in the tender for road works being invited by them and executed from funds received as Grant in Aid from the UT Administration or generated by them from any statutory powers conferred upon them (e.g. property tax etc.).

These issues with the concurrence of Finance Department and approval of Hon'ble Administrator, Daman and Diu and Dadra and Nagar Haveli.
