ORDER

Sub: Constitution of a Committee to accord permission for Road Cutting/ Digging- need for synchronization and coordination- regarding

A number of agencies such as PWD, OIDC, Local Bodies (District Panchayat, Municipal Council and Village Panchayat), Electricity Department, Telephone Department (BSNL) etc. are required to lay pipelines/cables for underground utilities, for which they are required to dig the road shoulders or carry out road cutting. It is absolutely essential and imperative that such activities of road cutting/digging of various agencies are well coordinated and synchronized.

- 2. A Committee under the chairmanship of Superintending Engineer, PWD, Daman, Diu and Dadra and Nagar Haveli is hereby constituted for according road cutting/digging permission for different Projects of Water Supply, Sewerage, Telephone etc. by Government/Semi Government Institutions Agencies/Industries etc. The officers of the UT of Dadra and Nagar Haveli will be Members for the permissions required in respect of roads in Dadra and Nagar Haveli and similarly officers of Daman shall be members for the permissions in Daman.
- I/c Superintending Engineer, PWD, DD&DNH. Chairman Member Associate Town Planner, Daman & Diu/DNH. Member Executive Engineer, PWD, Daman/DNH Municipal Engineer, Daman/DNH Member d. e. Executive Engineer (District Panchayat), Daman/DNH Member Executive Engineer, OIDC, Daman/DNH. Member f. Member Sub Divisional Engineer, BSNL g. Member Executive Engineer (Electricity), Daman / DNH h.
- 3. The Committee shall prepare an Annual Action Plan for road cutting/digging based on requirements of various agencies laying underground utilities and shall synchronize the activity of road cutting/digging amongst various agencies. The Committee shall meet at least once every month to review the plan and ensure that the requirements of various agencies is synchronized.
- 4. The Collector, Diu will constitute a similar committee for the permissions required in respect of roads in Diu District.
- 5. This is issued with the approval of Hon'ble Administrator vide diary No.2372 dated 18.6.2014.
