

(ii)	NGOs and Community Based Organizations (CBO)	01	(ii) The registration should have been obtained at least prior to three months of the Public Notice. (iii) Should be working in the jurisdiction of UT of Daman and Diu for respective district. (iv) Should have an office in Daman for Daman district and Diu for Diu district. (v) The NGOs, CBOs, RWAs and Associations should have proven track record of having worked for social causes. (vi) Preference will be given to organizations which are associated with the activities concerning upliftment, interest and welfare of Street Vendors and Hawkers etc. (vii) No criminal case should be pending against the NGOs, CBOs, RWAs and Associations and they should not have ever indulged in any fraudulent activity or misappropriation of funds. (viii) In case of individual members, they should have proven track record of social service and should also have aptitude and interest to work for the welfare of Street Vendors and Hawkers.

The NGOs, CBOs, RWAs and Associations may apply to the Deputy Secretary(UD), Urban Development Department, Daman for nomination as a member in the Town Vending Committee.
