NOTICE INVITING CLOSED BIDS FOR HARVESTING/ SALE OF CHIKOO FRUITS


Closed bids are hereby invited from the interested parties up to 12:00 Hrs on 23/08/2011 for harvesting/ sale of chikoo fruits from trees in the Govt. Seed Multiplication Farm, Kachigam, during the period w.e.f. 01/09/2011 to 30/06/2012, subject to terms & conditions given below:

TERMS AND CONDITIONS :-

1. The upset price for the bid is Rs. 45,140/-. The intended bidders are required to bid above the upset price.
2. The bid shall be given on plain paper and submitted in the name of Zonal Agriculture Officer, Daman in a sealed cover super scribed as "Bid for Sale of Chikoo Fruits".
3. The intended bidder is required to deposit an amount of Rs. 1130/- in the form of FDR/ Demand Draft drawn in favour of the Zonal Agriculture Officer, Daman along with the bid as "Earnest Money Deposit". Failing which, the bid will not be accepted.
4. The bids will be opened on 23/08/2011 at 05:00 PM in presence of the Members of the Committee constituted for the purpose and the bidders or their representatives, if any.
5. The highest bidder shall be the "successful bidder". The successful bidder shall have to deposit bid amount on the day of opening of bids with Zonal Agriculture Officer, Daman. Failing which, his bid will be treated as "cancelled" and his EMD will be forfeited to the Government.
6. The successful bidder shall have to deposit a Security Deposit of Rs. 2260/- by 29/08/2011 in the form of FDR valid up to at least one year from 29/08/2011. Failing which, his bid will be treated as "cancelled" and his EMD will be forfeited to the Government.
7. The EMD of the unsuccessful bidders will be released within one month from the date of opening of bids. The EMD of the successful bidder will be released within two months from the date of opening of bids.
8. The Security Deposit of the successful bidder will be released only after 30/06/2012, however, within twelve months from 01/09/2011 after deducting dues payable to the Government, if any.
9. The successful bidder shall have to deposit an amount of Rs. 2260/-, within ten days from taking over of the possession of the Chikoo Orchard, towards "Performance Guarantee".
10. The amount deposited against Performance Guarantee will be released only after successful completion of tenure granted to such bidder for harvesting of Chikoo Fruits after deducting dues payable to the Government, if any.
11. The Chikoo Orchard is open for the inspection by the intended person(s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Seed Multiplication Farm, Kachigam. The I/c of Govt. Seed Multiplication Farm,

- Kachigam has authority to deny such permission for the reasons not to be explained to the interested person (s).
12. After taking over the possession of the trees in the orchard, the successful bidder shall make the proper inventory showing the details, including the health status, of trees and obtain countersignature of the I/c of Govt. Seed Multiplication Farm, Kachigam.
 13. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful bidder has to compensate the same as per instructions of the I/c of Govt. Seed Multiplication Farm, Kachigam. Failing which, the bidder will not be allowed to continue the harvesting of Chikoo Fruits. The Government shall not be responsible for the damages occurred to the bidder on account of such discontinuation of harvesting. If required, his Security Deposit and Performance Guarantee lying with the department will also be forfeited to the Government in order to recover the losses caused to Government.
 14. The harvesting/ grading/ transportation/ sale of fruits is allowed on all working days during working hours till 30/06/2012 at the responsibility & cost of successful bidder.
 15. Assigning of any tree or trees in the orchard to other parties, by any mean, by the successful bidder is not allowed under any circumstances.
 16. All maintenance operations of the orchard will be carried out by the department at its own costs.
 17. The right to accept or to reject any or all bids, without assigning any reason thereof, is reserved with the Zonal Agriculture Officer, Daman.
