

NOTIFICATION

The following draft amendments in the existing the Daman & Diu Panchayats (Election Procedure) Rules, 2014, which the Administrator, UT of Daman & Diu, proposes to make in exercise of the powers conferred by the sub section (1) and sub section (2) of section 121 read with sub section (2) of section 55 of the Daman & Diu Panchayat Regulation, 2012 (No. 4 of 2012), are hereby published, as required by sub section (1) of 121 of the said Regulation and notice is hereby given that draft amendments in the existing said Rules will be taken into consideration on the expiry of a period of Forteen (14) days from the date of publication of this notification in the official Gazette of UT Administration of Daman & Diu.

Any person, who intends to make any objection or suggestion regarding these draft amendments, may send the same in writing addressed to the Deputy Secretary (PRI), Secretariat, Moti Daman – 396 220, within the period specified above.

Contd.....

1. Short title and commencement :

(1) These rules may be called the Daman and Diu Panchayat (Election Procedure) (Amendment) Rules, 2015.

(2) These rules shall come into force from the date of publication in the Official Gazette of Daman & Diu.

2. Amendment of Rule 3(d):

In place of Rule 3(d) in the existing rules, following shall be substituted (d) thereafter,

- (i) by one or more orders, determine the delimitation of Gram Panchayat ward;
- (ii) convey its recommendations regarding delimitation of District Panchayat ward to Administrator for final decision and to be published in the Official Gazette.

3. Amendment of Rule 4(1):

In place of Rule 4(1), in the existing rules, following shall be substituted –

- (1) The Election Commission shall cause each of its order made under Rule 3(d)(i) to be published in the Official Gazette.

Any objection and suggestion thereto should be submitted to the undersigned in writing between 10.00 a.m. to 4.00 p.m. on all working days, within a period of 14 days from the date of publication of this notification.
