

The public auction of condemn vehicle will be done as per the following terms and conditions.

TERMS AND CONDITIONS.

1. The Auction shall be held on “As is where is basis” on bid system. Interested bidders shall have to deposit a token of Rs. 2,500/- (in cash only) at the time of auction for taking part in the process. The said amount shall be refunded back to the unsuccessful bidder after the auction.
2. The Successful bidder has to deposit 10% of the offered bid on the spot.
3. The ‘Reserved’ Price of the vehicle is fixed at Rs. 50,000/- (Rupees Fifty Thousand Only). An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times, uninterruptedly and at the fall of hammer.
4. The successful bidder shall have to lift the auctioned vehicle within (3) three days after deposited remaining offered bid amount from the days of finalization of the auction after which this office shall not be responsible for its safe custody.
5. The interested parties may inspect the vehicle on “As is where is basis” and satisfy themselves about its conditions, etc., during office hours on any working day.
6. A bid shall be considered as final only after the approval of the Committee whose decision shall be final and binding upon all the bidders participating in the auction.
7. The right to accept or reject any bid or all the bids, without assigning any reason, is reserved with the Competent Authority.
8. The successful bidder must submit a copy of his/her PAN Card, residence proof i.e. Ration Card, Voter ID Card, Aadhar Card, etc. without which his/her bid will not be entertained.

9. The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse in this regard.
10. Dispute, if any shall be subject to Daman jurisdiction only.
