

Sealed Tender are hereby invited by the undersigned, on the behalf of President of India from the interested Firm/Fabricators/Manufactures for repairing works of 67 Barricades lying at Police Head Quarters, Dunetha, Nani Daman, as per schedule attached, so as to reach this office on or before 20/07/2015 up to 15.00 hrs. by RPAD/post or Courier in the office of the undersigned.

1. The envelope should be super scribed by words Tender for "REPAIRING WORKS OF BARRICADES"
2. The rate should be quoted only for specific items and inclusive of all taxes if any applicable and F.O.R. at Daman.
3. The Tender will be opened on the same day, if possible, in presence of Firm/Fabricator/Manufacturer, who will remain present at the time of opening.
4. Barricades shall be repaired at the Police Head Quarters, Nani Daman and shall be repaired within a month time from the date of issue of supply order/work order.
5. Tender Fee of Rs. 500/- to be paid in favor of Dy. Inspector General of Police, DD&DNH, Daman (Non-refundable). Tender received without Tender Fee, will be summarily rejected.
6. E.M.D. of Rs. 12,500/- in the of F.D.R. issued by any Nationalized Schedule Bank in favour of the Dy. Inspector General of Police, DD/DNH, Daman. May be enclosed with the limited tender. Tender received without E.M.D. will be summarily rejected.
7. Tender received after due date & time will not be taken into consideration.
8. Payment will be made only after the satisfactory completion of repairing works of the Barricades.
9. If any repairing work found to be of inferior then it shall be replaced or re-repaired by the Firm/Fabricators/Manufactures, at his own risk and cost.
10. The materials used for repairing work should be of standard Quality.
11. The Firm/Fabricator/Manufacturers must have SST/CST/TIN registration with the Govt. Department concerns.
12. The undersigned has reserves the right to reject any or all Tender without assigning any reasons, at any stage.
13. The rate shall be valid up to 31/12/2015 and it inclusive of all applicable taxes.


TERMS AND CONDITIONS

3. The right to accept or reject any tender in part or whole without assigning any reasons, is reserved with the Tender Inviting Officer Dy. S.P. HQ, Daman (DDO) and his decision(s) on all matters relating to acceptance or rejection shall also be final.
4. The successful tendered will have to deposit an amount equal to 10% of the total value of the Tender in form of security deposit within 05 days after issuing supply order/work order, in form of F.D.R. Non receipt of the security deposit within stipulated time period will result in automatic cancellation of the order for supply without any intimation.
5. The amount of E.M.D. deposited by the tenderer(s) whose tender are not accepted will be refunded to them by the Tender Inviting Officer.




