2. To draft affidavit/written statements in the concerned cases in consultation with the Member Secretary, Pollution Control Committee, DD & DNH and to file the same before Supreme Court/High Court/National Green Tribunal after duly approved by the competent authority.
3. To provide legal opinion to Pollution Control Committee, DD & DNH wherever the cases are referred to the firm and to submit the case status pertaining the cases of Pollution Control Committee, DD & DNH/ UT Administration.
4. The tenure of engagement of law firm shall be for one year from the date of issue of work order.
5. The expression of interest alongwith the charges/rates for the professional legal work/services on retainership including taxes and misc out of pocket/stationery expenses should be submitted in the office of the Member Secretary, Pollution Control Committee, DD & DNH, 1st floor, Udyog Bhawan, Bhenslore, Nani Daman on or before **23/07/2019**.
