

4. The rates should be quoted by the firms who have already stock and are able to start the work within 7 days after issue of clear supply/work order by this department.

5. The partition work should be completed within one month from the date of issue of work order after the work completion, the EMD will be refunded in respect of L1 agency.
6. Material used/supplied should be genuine in nature and should be latest and not from the dead stock.
7. The material found defective or damaged or otherwise not as per specification given, shall be rejected. The firm should replace it otherwise payment will not be made.
8. The internal panel electrification work/EPABX/Internet Connection, etc. through the partition panel and work places shall be done by the agency.
9. During the work of the partition all care will be taken by the agency so as not to cause any damage to routine office files/ records/stocks/ furniture/ equipments etc., failing which the responsibility is fixed on the agency side.
10. Bill in duplicate duly pre-receipted along with the bank account details may please be sent to making necessary payments.
11. Original bill should be signed by the authorized person on revenue stamp.
12. Payment shall be released only after completion of work at the satisfaction of the representative of this office.
