

Term & condition:-

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal along with tender form.
- 2 The interested parties should have the above mentioned items ready in their stock for supply. The delivery is to be made at Govt. Horticulture Farm, Moti Daman. within 07 days, from the date issue of supply Order.
- 3 The rates should be inclusive of all taxes with transporting and other charges etc. & valid up to 180 days from the date of opening of tender.
The firms which have been blacklisted by any Govt. department are not eligible to participate in this tender.
- 4 The Rate should be quoted by the registered distributors / dealers / suppliers / authorized firms to supply the Laal Wal Seeds (Pulses - Laal Wal Seeds Desi) immediately within 07 days from receipt of the clear order from this office.
- 5 The Bidder should ensure that he has to follow all the guideline of Corona virus/Covid -19 and others issued by the Govt. of India/ U.T. Administration from time to time.
- 6 The Bidder is himself responsible for supply of Seeds through vehicle etc. including obtaining vehicle permission etc. from the competent authority during the period of Lockdown.
- 7 The EMD of ₹. 7, 500/- should be furnished in the form of FDR / DD drawn in the favour of Chief Executive Officer, District Panchayat, Daman and the same should be enclosed with sealed tender document. Tender received without specified EMD shall be summarily rejected. EMD of the Successful Tenderer will be release on issue of certificate from the Govt. Horticulture Farm Authority regarding completion of supply of seeds. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
- 8 The Seeds to be supplied should be healthy and free for pest & diseases have been produced/ manufactured, packed, labeled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 9 The supplies which found to be defective or in damage condition or otherwise not conforming to the given specifications will be rejected. The supplier has to replace the same within specified period of time.
- 10 The Bidders should submit the copies of the Registration Certificate of Seeds license, PAN Card, copy of ITR for last two years, GST Registration Certificate.
- 11 No Advance payment will be made until materials is received and will be paid on passing of bill. The payment will be made only direct bank account through RTGS only after successful completion of supply to the satisfaction of the Chief Executive Officer, District Panchayat, Daman.
- 12 The tender forms alongwith terms and conditions can be also downloaded from website www.daman.nic.in on payment of Rs. 500/- towards Tender fee (non-refundable) in form of DD drawn in the name of Chief Executive Officer, District Panchayat, Daman from any Nationalized bank to be submitted alongwith tender document.
