ORDER

In exercise of the powers vested in the Administrator under Rule 18 of the Delegation of Financial Powers Rules, 1978, the Administrator of Daman & Diu and Dadra & Nagar Haveli is pleased to authorize the following officers to exercise powers conferred on the Administrator to accord expenditure sanction of works to the extent of amount indicated against each as under in the UTs of Daman & Diu and Dadra & Nagar Haveli.

Sr. No.	Authority	Extent of Powers
1.	Development Commissioner, Daman & Diu and Dadra & Nagar Haveli	₹ 150 lac
2.	Finance Secretary, Daman & Diu and Dadra & Nagar Haveli	₹ 150 lac
3.	Collector, Daman (for Daman district)	₹ 50 lac
4.	Collector, Diu (Cadre officer only for Diu district)	₹ 50 lac
5.	Collector, Dadra & Nagar Haveli for Dadra & Nagar Haveli	₹ 50 lac
6.	Chief Conservator of Forests	₹ 50 lac

These powers are subject to availability of specific budget provisions for the respective works and due observance of the provisions of General Financial Rules 2005, Delegation of Financial Powers Rules, 1978, CPWD Manual/Code and other orders/instructions/circulars/directions, etc. issued by Government of India, Ministry of Home Affairs, Ministry of Finance, Planning Commission, CVC and Other Ministries and U.Ts. Administration from time to time.


The powers delegated shall be exercised subject to the overall supervision and control of the Administrator.

This supersedes all earlier orders of re-delegation of powers to accord Administrative Approval & Expenditure Sanction to works.
